- 4. This extension of provisional affiliation is subject to the condition of deposit of Affiliation fees of ₹80000/- (Eighty Thousand only) vide DD or vide NEFT/RTGS (Details attached) which must be deposited within a week from the date of receipt of this letter.
- 5. This extension of provisional affiliation is subjected to attending all the deficiencies/ shortcoming/advices/suggestions pointed out by the Inspection team in its report dated 12-04-2018 (Remarks copy attached) within a period of three months from the date of issue of this letter as mentioned below:

  - e. The faculty has only 2 Ph.D. and two NET qualification. The rest should get qualified with NET/Ph.D.
  - The teacher be encouraged to participate in seminar and orientation programme.
- 6. Further you have to inform the university through affidavit that you have removed all the deficiencies/ shortcoming/advices/suggestions as intimated to you vide "5" above.

7. The University may inspect your college at any working day without information to check the infrastructure as well as the academics activity of your college as per guidelines of NCTE/GoB/AKU.
