This has reference to your submitted proposal regarding grant of extension of provisional affiliation of Bachelor of Education (B.Ed.) Course of your institute for academic session 2024-25 .

On the basis of the report of the Inspection team and as per the recommendations of the Board of Affiliation in its 64th meeting held on 21/06/2024 and approved from The Court of the University in its 25th meeting held on 24.06.2024, the University is pleased to grant the extension of provisional affiliation for the academic session 2024-25 on the following terms & conditions:

1. This extension of provisional affiliation is granted with an annual intake of 100 seats (2 basic units) for one year (academic session 2024-25).
2. This extension of provisional affiliation is based upon the approval accorded to your institute by the NCTE vide F.ERC/NCTE/ERCAPP1267/B.Ed. (Revised order) 2015/31642 dated 13-05-2015.
3. This extension of provisional affiliation is subject to attending all the deficiencies/ shortcoming/ advices/suggestions pointed out by the Inspection team in its report dated 18.06.2024 (Remarks copy attached) within a period of three months (90 days) from the date of issue of this letter.
4. This extension of provisional affiliation is also subject to approval of list of teachers & Principal presently working in your institute alongwith the proceeding of the selection committee for the same.
5. Further you have to inform the university through affidavit that you have removed all the deficiencies/ shortcoming/advices/suggestions as mentioned in coloumn "3" & "4" above.
6. The information furnished in respect to above course should be factual and correct. In the event of any information found to be false, misleading or suppressed, the extension of provisional affiliation shall be withdrawn by the university without any further notice.
7. The University may inspect your institute at any working day without information, to check the infrastructure & instructional facilities as well as the academic activities of your institute as per guidelines of NCTE/UGC/GOB/AKU from time to time.
8. The selection of candidates for admission to the Bachelor of Education (B.Ed.) in regular mode shall be made on the basis of merit obtained in Combined Entrance Test-B.Ed. (CET-B.Ed.) for the year 2024 conducted by Nodal University, Lalit Narayan Mithila University, Darbhanga.
9. The college is also directed to maintain the attendance as per University norms of students through Biometric/Manual/ERP.




10. The college is directed to ensure that payment of all teaching/non teaching staff should be made through RTGS/NEFT after due deduction of EPF/ESI.

Kindly refer to your proposal regarding establishment of new institute on the above noted subject.

On the basis of Hon'ble Supreme Court judgment of the case no. 295 dated 24-06-2013 and the report of the Inspection Committee which visited your proposed institute on 06-07-2013 to verify the various infrastructural facilities provided for running B.Ed. (1 year degree) course and in view of approval of the NCTE and recommendation of different committees i.e Affiliation & New Teaching Programme Committee, Board of Affiliation & The Court , the Hon'ble Vice-Chancellor has been pleased to grant provisional affiliation for one year to Mundeshwari College for Teacher Education, Vill/P.O- Sarari, Tehsil/Taluka - Danapur, Patna, Bihar- 801 105 for starting Bachelor of Education with 100 seats w.e.f. the session 2013-14, subject to approval by the state government.

The above provisional affiliation is subject to fulfillment of all the observations/shortcomings pointed out by the Inspection Committee in its report dated 06-07-2013 (copy enclosed). The admissions to the said course shall be made through competent authority.

Endowment and Affiliation fees must be deposited within a week of the receipt of this letter. In case of non-compliance no further processing of affiliation will be done.

You are, therefore, requested to submit the compliance of deficiencies pointed out within a period of six months and submit the compliance report on affidavit. In case of non-compliance of deficiencies pointed out in the inspection report, the university shall have the right to refuse the extension of provisional affiliation to the institute for the next academic session.
